2. Epoxy Flooring Subcontractor has indicated that he would not recommend detail 4/A5.0 for the epoxy flooring installation. Termination points for urethane cement flooring should be saw-cut and chased into the slab in order to lock the system in place. He would recommend a transition strip that can be applied after their installation. Please review attached alternate detail for termination of Epoxy Flooring system your review and approval.
3. Please confirm that FRP is not required in the Yeast Lab 114.
4. Are the existing to remain concrete floors to be sealed/polished?
5. Room 111 calls for the Epoxy Cove Base but existing concrete floor to remain. Is epoxy flooring required in this area? Please confirm finishes.
6. Women's & Men's Restrooms – Tile behind the mirror walls - CT-02 is listed on the finish schedule and CT-01 on the finish plan. Please confirm which is correct.
